## Service Above Self

Rotary began in Chicago in 1905. Paul Harris, a young lawyer, invited 3 friends, engaged in different organizations, to form a club to promote friendship and occupational understanding. Originally, the meeting locations "rotated" among members' offices, hence the name "Rotary". By 1910 there were 16 clubs in the United States. Early mottos recognized Rotary's commitment to the idea of service, "He Profits Most Who Serves Best" and "Service Above Self." In 1989, the Rotary International Council on Legislation established "Service Above Self" as the organization's principal motto.

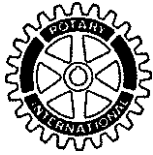
## Objective of Rotary

The main objective of a Rotary club is service in the community, in the workplace, and throughout the world. Rotary International has developed a broad range of programs designed to help clubs carry out this vital mission. Rotary's community development programs address many of today's most critical issues like health, hunger, the environment, and literacy. The international component of Rotary International enables clubs and districts to assist Rotary efforts abroad and to share information and arrange exchanges with Rotarians in other countries. Many club and district projects focus on vocational issues, promote high ethical standards in the workplace, and help young people to become and remain productive members of Society.

## New Member Procedures and Proposal Form

### New Member Procedures:

1. Before proposing a new member, it is good practice for the sponsor(s) to introduce a prospective new member **as a guest at one or two club meetings.**
2. The sponsor(s) should then submit this membership proposal form to the Membership Chair.
3. Upon Membership Committee and Board of Directors approval and absent protest after publication, the Membership Chair will inform the prospective new member of his or her eligibility to join.
4. The new member must complete a member data form and *give* it to the club secretary so he or she can be officially enrolled. The new member will then be billed for club dues and initiation fees.
  - a. Annual Dues - \$250 for individual / \$350 corporate billed July 1<sup>st</sup>. These are international & district membership dues that provide you with an official Rotary ID number. If you join Rotary mid-year, your annual dues are pro-rated by month.
  - b. Dues can be paid in installments up to December 31<sup>st</sup>
  - c. New members are charged a one-time \$50 club set up fee for badge, pin, member pkg. etc.
  - d. Breakfast is \$15.00 by cash or quarterly billing
  - e. Coffee is complementary.
  - f. Each member is charged \$30.00 per month for facility rental of the meeting location billed quarterly.
  - g. Rotary shirts are \$54.00 for purchase to be worn at Rotary functions.
5. Meetings are held at LEX – Lloydminster Exhibition - Aspen Room, Tuesday mornings at 7:00 am.
